Trial of this case was held October 28-October 30, 2025. The Plaintiff was represented by attorney Martin Diaz, and the Defendant was represented by attorney William H. Roerman. The Proceedings were held as shown in the record.

The jury commenced deliberations at approximately 1:35 PM, Thursday, October 30, 2025. At approximately 3:33 PM, Thursday, October 30, 2025, the jury returned a verdict in favor of the Plaintiff.

The Court finds that the verdicts are in proper order. The Court hereby accepts the jury verdicts and directs the Clerk of Court to enter the verdicts into the record. Pursuant to the jury verdict, the Court finds that the Plaintiff has proven the elements of its claims of negligence to include: 1) past physical pain and suffering for Aiden Holtkamp and 2) past physical pain and suffering plus 3) past loss of function of body for Monique Holtkamp.

IT IS ORDERED that the resulting damages of \$2,500 for past physical pain and suffering and \$7,500 for past loss of function of body, totaling \$10,000 for Plaintiff Monique Holtkamp, plus \$250 for past physical pain and suffering for Aiden Holtkamp, as well as statutory interest as of this date, are duly awarded to the Plaintiff. Court costs are assessed to the Plaintiff.
